Those objections being - loss of agricultural land; increased volume of traffic; pressure on schools and doctors; lack of access to the estate; density of affordable housing.

2. Declarations of interest and dispensation requests for relevant items None received.

3. Approval of minutes from meeting held on Monday 31st October 2016

It was noted Mark Taylor was in attendance at this meeting but had been missed from those in attendance. Minutes were then approved and signed as a true and accurate copy.

4. Clerk Report and matters arising from minutes

Standing orders updated on website and the Freedom of Information Act also added. Pot holes on Spalding Road/drainage kerb missing/column 23 High Street, Gosberton reported to LCC on 7th November 2016 – all attended to apart from the light out – **action clerk to re-report**

Cllr Clark visited resident on Spalding Road regarding issue regarding access across land and confirmed the land is owned by parish council.

<u>Resolved:</u> to write to resident giving him permission to cross access road to be renewed annually to prevent any ownership rights – **action clerk.**

Permission sought from Diane Fairchild from SHDC for crown lifting trees at Gosberton Playing field – form now received for completion for permission.

5. To receive and consider budget

Draft budget was sent out prior to meeting for consideration. Comments received were to amend allotment rent to show increase for next year's rent.

Resolved: to consider further at Finance and Policy Working Group meeting.

6. To consider forming a Traffic Calming Focus Group and a Playing Field Action Group

No interest was shown in forming either group. It was suggested maybe interested residents form their own forum and feedback to the parish council. To find out whether anyone can be responsible for accessing information for interactive speed sign and maybe give that responsibility to a resident to monitor.

<u>Resolved:</u> clerk to enquire about interactive sign information and defer any action regarding the Group until after sign erected – **action clerk**.

To contact Emma Walters regarding action group for playing field to seek ideas for future use now ownership is with the parish council. A carpark was suggested by Cllr Pell.

Resolved: to make enquiries with SHDC to see what needs to be in place with regards planning permission for carpark – **action clerk**

7. Parish Matters and Police Report

Harecoursing x 2 Chopdyke Drove; Mud on the road Gosberton Bank; RTC Spalding Road; RTC x 3 Boston Road; Mud on road Northgate; Mud on road Watergate; Harecoursing Beck Bank; RTC Wargate Way; RTC Beach Lane; Harecoursing abandon vehicle (broken down and vandalised) Beach Lane; Harecoursing Second Drove Gosberton Clough.

Trees near playing field need trimming as obstructing light.

Resolved: to seek permission to cut trees from Highways.

Road surface on Boston Road, Gosberton from Lincolnshire Wildlife Trust Pits to Neame-Lea Nurseries needs reporting to LCC as unsafe – **action clerk**.

The hedge still needs cutting at playing field at Gosberton. Further quote still required from other companies – **action chairman.**

Clerk asked what contract Sneath's were on with the PC but there is no contract. It was suggested quotes should be obtained for future grass cutting.

9. Finance and Policy Working Group report from meeting held Tuesday November 2016

Items discussed were clerk contract; financial regulations; auditor contractor; additional bank account needed for charitable donations; reserves for purchase of cemetery land; collation of essential policies is on-going.
