## 4. Police Report

Incidents reported since last meeting - 2 thefts and 1 hare-coursing.

Cllr Allen raised the youths drinking in the park throwing bottles and PCSO Abbotts was aware but had not been able to catch anyone there but will continue to monitor situation.

#### 5. Clerk Report

Clerk has spent time with clerk of Holbeach Parish Council for training needs and she is very grateful for her time and help.

Accounts have been finalised for end of quarter two and internal audit is due to be carried out in next couple of weeks – date tbc.

Trees have been pollarded in the churchyard by Arb-Core and two trees identified as needing removing. Deborah Reynolds has been advised.

Discussions had around speed signs.

Quote received from Eddie Mears for levelling of the trees at Gosberton playing field. Further quote to be received from Arb-Core – **action Chairman.** 

Cllr Clark had had a discussion with Richard Sneath regarding the grass cutting and he had suggested the grass was cut twice more a year and possibly with a different mower.

Resolved: Cllr Clark to discuss contract with Richard Sneath for future works.

Cllr Clark advised the rocking horse was taking shape. Seat still to be made - action MP.

Cllr Clark advised the lawn mower had been fixed and was now working well. Nothing to report for Gosberton Risegate
